






BREEAM In-Use FactFile 2017



Average BREEAM In-Use ratings


Overall assessment ratings by Part: Asset Performance (Part 1), Building Management (Part 2), Occupier Management (Part 3)






Average environmental category scores


Environmental category scores: Nine environmental categories across all three assessment parts






Performance by Country









Performance by Asset Type

Average environmental category scores by Asset Type -Asset types with the highest BREEAM In-Use uptake (Top 3)







